AGREEMENT FOR THE USE OF THE ILAC MRA MARK BETWEEN THE

International Laboratory Accreditation Cooperation (ILAC) AND AN

ILAC Mutual Recognition Arrangement signatory (ILAC MRA signatory)

- 1. This Agreement, effective as of the 7th of September 2015, by and between the International Laboratory Accreditation Cooperation (herein referred to as ILAC) with a registered place of business at Mariaplaats 21 d, 3511 LK Utrecht, the Netherlands and the Egyptian Accreditation Council (herein referred to as the ILAC MRA signatory), with a registered place of business at Borg Riad E1-Maadi (1), Kornish E1Nil, Maadi, Cairo, Egypt.
- 2. ILAC is the owner of the ILAC MRA Mark registered in Egypt with the following international trademark registration number: 840857.
- 3. ILAC grants permission to the ILAC MRA signatory to use the ILAC MRA Mark as per the terms set forth herein and as per the ILAC document *ILAC-R7 Rules for the Use of the ILAC MRA Mark*, as updated periodically by ILAC and communicated to its members.
- 4. ILAC grants permission to the ILAC MRA signatory to use the Combined ILAC MRA Mark subject to the provisions set out in ILAC-R7.
- 5. Upon signing this Agreement, the ILAC MRA signatory may grant permission to its accredited conformity assessment bodies (CABs) to use the Accredited CAB Combined ILAC MRA Mark subject to the provisions set out in ILAC-R7.
- 6. ILAC reserves the right to terminate this Agreement in writing when the ILAC MRA signatory is in default of its obligations under this Agreement and it has not repaired the default within thirty (30) days of receipt of a written notice from ILAC.
- 7. This Agreement terminates automatically and immediately without the need for prior notification when:
 - a) The ILAC MRA signatory is suspended from the ILAC MRA;
 - b) The ILAC MRA signatory's ILAC membership is terminated;
 - c) The trademark application is refused, the trademark registration is cancelled by trademark authorities or the trademark registration is not renewed.
- 8. Upon the termination of this Agreement, the ILAC MRA signatory and their accredited CABs no longer have the right to use the ILAC MRA Mark.
